IN THE MATTER OF THE ORGANIZATION OF A NEW TOWN OUT OF PARTS OF THE TOWN OF: ARMSTRONG, OCONTO COUNTY, STATE OF WISCONS IN.

ORDER CREATING TOWN D O T

A Petition having been made and presented to the Circuit court of Oconto County, Wisconsin, praying for the detachment of certain portions of the town of Armstrong and the organization of a new town out of said portions to be known by the name of the Town of Doty, and the Court having by an order dated January 4th A D 1922, fixed the time for the hearing of the said petition and having ordered the publication of a notice of such hearing in the Gillett Weekly Times, a weekly newspaper published at Gillett, Oconto County, Wisconsin, as most likely to give notices to the residents of said town of Armstrong, and

The Court having directed that a copy of the petition and order for hearing be served on the clerk of the town of Armstrong at least fifteen (15) days before the time fixed for hearing, and

Due Proof having been made and filed that notice of such hearing was duly published in the Gillett Weekly Times, a Weekly newspaper designated by the court as most likely to give notice to the people of the town of Armstrong, once each week for three successive weeks, the first publication being on the 27th day of January, A D 1922, and the last publication being on the 17th day of February A D 1922, and due proof of such publication having been made and filed, and

A Copy of the petition and the order aforesaid having been served upon the town clerk of the town of Armstrong, at said town, at least fifteen (15) days before the time fixed

for hearing of the said petition, to-wit: on the 24th day of January, A D 1922, and due proof of such service having been made and filed, and

The Circuit Court for Oconto County, Haing fixed the time and place of hearing the said petition as (9) o'clock in the forenoon of the 4th day of March A D 1922, at his Chambers, in the city of Marinette, Marinette County, Wisconsin, and said petition having been duly heard on the said day, four petitioners appearing in proper person and by George Crawford, their attorney, and

It Appearing to the court that the said petition was duly signed by a majority of the electors and a majority of the resident freeholders and homesteaders of the proposed town, and it further appearing that said proposed town has at least forty (40) resident freeholders or homesteaders at least twenty five (25) of whom are electors who have resided within such territory at least one year prior to the 4th day of January A D 1922, being the date of the verification of the petition, and

It appearing that the proposed new town of Doty, has an assessed valuation exceeding one hundred thousand dollars (\$100,000.co) according to the last preceding assessment, and that the remaining area of the town of Armstrong consists of more than thirty six (36) square miles, and that it has not less than fifty (50) resident electors and an assessed Valuation exceeding one hundred thousand dollars (\$100,000.co) according to the last preceding assessment, and

It appearing that the said petition is verified by five signers; That it contains the name of the proposed new town; the name of the town of which it forms a part; the names of the electors, and that it contains an accurate description of the territory sought to be organized into said new town of Doty, and the petitioners having in all matters fully complied with the provisions of Chapter 60 of the Wisconsin Statutes as amended, The Court being fully advised in the Premises,

It is on Motion, of George Crawford, attorney for said petitioners,

ORDERED AND ADJUDGED, That the following described territory be detached from the town of Armstrong and that the same be and there is hereby created out of such territory a new town to be known as the town of Doty.

Said territory comprising said new town of Doty as aforesaid is described in the petition, and is now hereby fixed and described as follows: To-wit: Sections number (7), to sections Number thirty six (36), both inclusive all in township number thirty two (32) North of Range Difteen (15) East, and sections Number one (1) to sections number four(4) both inclusive sections number nine (9) to sections number sixteen (16) both inclusive, sections number twenty one (21) to sections number twenty eight, both inclusive and sections number thirty three (33) to sections number thirty six (36) both inclusive all in township number thirty one, North of Range fifteen (15) east, the same being part of and lying within the Town of Armstrong, Oconto County, Wisconsin.

IT IS FURTHER ORDERED, That the first meeting of the new town of Doty be held in said town at the residence of Richard T Davis, situated on the North West Quarter of the North West Quarter of section number thirty five, township number thirty two, range fifteen east, town of Armstrong, Oconto county, Wisconsin, now the town of Doty, as by law provided.
